[Answer from MHLW: Ministry of Health, Labour and Welfare]

All the emergency workers in Fukushima Daiichi Nuclear Power Plant will be obliged to have compulsory medical checkups implemented by their employers every 6 month as they are engaging radioactive works. They also have chances to have health counseling and additional medical checkups during their employment by their employers based on the guidelines of MHLW.

Emergency workers who exposed more than 50mSv in the emergency works will be given occasions of cataract verification once a year as an additional medical checkup, while those who exposed more than 100mSv will be given thyroid testing and three types of cancer screening: stomach, colon and lungs. During their employment, their employers will provide additional medical checkups, and MHLW will provide them after their retirement from radioactive works.

To streamline the above program, MHLW have developed a database system which collects records of radiation exposure and medical checkups of all emergency workers of the Plant. The employers are obliged to report their workers' records of radiation exposure and medical checkups to the MHLW.
